AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky

Board of Chiropractic Examiners, hereinafter referred to as the "Board," and

Donald R. Miller D.C., hereinafter referred to as the "Respondent";

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS

Chapter 312 and the related administrative regulations;

History

WHEREAS, the Respondent is an associate doctor with Millpond Family

Chiropractic; and

WHEREAS, The Respondent's violated several sections of KRS 312, and

associated Administrative Regulations including;

- 1.) KRS 312.145(3) and 201 KAR21.065(6) Failure to have proper signage at the facility with compliant naming convention.

diligently in the future to insure that all advertising issued by the Respondent, or on the Respondent's behalf, complies with KRS Chapter 312 and the accompanying administrative regulations;

3) The Respondent, Donald R. Miller D.C., shall pay a fine to the Board in the amount of five thousand dollars (\$5,000.00). Said fine shall be made payable to the "Kentucky Board of Chiropractic Examiners."

- a. Said fine may be paid in monthly five hundred dollar (\$500.00) installments due postmarked by the 12th day of each month.
- b. Respondent agrees that failure to pay each installment in a timely manner will result in a penalty of \$250 for the first thirty (30) days and \$25 per each day thereafter.
- c. Respondent further acknowledges that should he fail to pay timely, the Board may seek additional sanctions as a violation of KRS 312.150 and 201 KAR 21:015.


4) The original, executed Agreed Order and initial fine payment must be received in the office of the Board, *postmarked no later than February 16th, 2018.*

5) The Respondent agrees to a suspension of his license to practice chiropractic for one hundred eighty (180) days, however the suspension shall be probated for a period of twelve (12) months. The probated suspension shall be served if and only if the Respondent violates KRS 312 or 201 KAR Chapter 21, which includes failure to comply with the terms of this agreed order, within the probationary period, and is convicted by the Board of that violation

Complete Agreement

This Agreed Order consists of five (5) pages and embodies the entire agreement between the Kentucky Board of Chiropractic Examiners and Donald R. Miller, D.C.. It may not be altered, amended or modified without the express written consent of both parties.


