AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and James Aaron Coursey D.C., hereinafter referred to as the "Respondent";

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations;

History

WHEREAS, the Board received notification that the Respondent was charged with one count of Tampering with Physical Evidence in violation of KRS 524.100 on September 2, 2014; and

WHEREAS, the Board received notification that the Respondent was charged with ten counts of Possession/Viewing of Matter Portraying Sexual Performance by a Minor in violation of KRS 531.335 on September 5, 2014; and

WHEREAS, the criminal matter at issue here is ongoing; and

WHEREAS, it is proper to allow the criminal charge to be finally resolved or adjudicated prior to any disciplinary action being taken by the Board; and

WHEREAS, it is the Board's primary interest to protect the public during this legal process; and

WHEREAS, the parties mutually desire to accomplish this protection, without the need for a formal hearing at this time.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that this matter shall be settled and resolved upon the following terms:

- 1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the Respondent under KRS Chapter 312 and the accompanying regulations;
- 2) The Respondent, James Aaron Coursey, D.C., acknowledges that this Agreed Order does not constitute a final resolution of the underlying issues;
- 3) The Respondent agrees to keep the Board informed of the status of the aforementioned case. The Respondent agrees that he shall cause the Board Office to receive a copy of any order which causes that criminal action to be finally resolved within five (5) days of its entry;
- 4) The Respondent agrees to have a female staff member present in the room during all treatment or examination of female patients. Further, the

Respondent agrees that he shall not treat minor patients.

5) The Respondent, James Aaron Coursey, D.C., agrees that he shall offer his full cooperation in all Board investigations or inspections; and

6) The original, executed Agreed Order must be received in the office of the Board, *prior to the reinstatement of the license from the Temporary Emergency Suspension Order from September 10, 2014.*

7) The Respondent, James Aaron Coursey, D.C., agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the Board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

Voluntary Waiver of Rights

The Respondent, James Aaron Coursey, D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.

Publication of Settlement Agreement

The Respondent acknowledges that, once adopted by the Board, this Agreed Order may be considered a public document, available for inspection at any time by any member of the public under the Kentucky Open Records Act, and may be reportable under federal law. This Agreed Order may at any time be published on the Board's website, www.kbce.ky.gov.

Complete Agreement

This Agreed Order consists of four (4) pages and embodies the entire

agreement between the Kentucky Board of Chiropractic Examiners and James Aaron Coursey, D.C.. It may not be altered, amended or modified without the express written consent of both parties.




