

#### AGREED ORDER

#### **Parties**

**WHEREAS,** the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and James K. Hanlon, D.C., hereinafter referred to as the "Respondent."

#### Jurisdiction

**WHEREAS,** the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

#### History

**WHEREAS,** the Respondent entered into an Agreed Order for violation of KRS 312.150(2)(h) on November 22, 2103; and

**WHEREAS,** the Respondent violated the Agreed Order and entered into a second Agreed Order which included serving the previously probated thirty (30) day suspension, and completion of the previous terms, on January 12, 2105; and

**WHEREAS,** the Board received a complaint on May 21, 2015, that Dr. Hanlon had practiced during his suspension; and

**WHEREAS,** the Respondent failed to complete the terms of the Agreed Order by the deadline; and

**WHEREAS,** the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

# Terms of Agreement

**THEREFORE, it is hereby agreed** between the undersigned parties that this matter shall be settled and resolved upon the following terms:

- 1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the respondent under KRS Chapter 312 and the accompanying regulations;
- 2) The Respondent, Dr. James K. Hanlon, D.C., acknowledges that the Board has grounds to file allegations of violations of KRS 312.150(1)(g) and 201 KAR 21:015 Section 3(2). In the interest of settling this case in an expeditious manner, the Respondent agrees to the following terms set forth in the subsequent paragraphs;
- 3) The Respondent, Dr. James K. Hanlon, D.C., hereby agrees that, effective on September 14, 2015, his license shall be revoked pursuant to this Agreed Order;
- 4) The original, executed Agreed Order must be received in the office of the board, postmarked no later than September 14, 2015.

- 5) The Respondent shall, prior to making an application for licensure with this Board pursuant to KRS 312.085 or KRS 312.175, successfully complete the Ethics and Boundaries examination of the National Board of chiropractic Examiners, with proof submitted to the Board;
- with this Board pursuant to KRS 312.085 or KRS 3L2.I75, obtain a psychological evaluation at Respondent's expense from a psychologist who is certified and in good standing with the Kentucky Board of Examiners of Psychology and approved by the Kentucky Board of Chiropractic Examiners. Prior to examination, the psychologist shall be made fully aware of the factual allegations underlying this complaint and that the evaluation is for the purpose of identifying risks related to the Respondent's fitness to practice. The psychologist shall forward a copy of the complete psychological report to the Kentucky Board of Chiropractic Examiners;
- 7) The Respondent acknowledges that fulfillment of the above conditions are a necessary condition for licensure in the future. However, the fulfillment of the above conditions may not be sufficient to achieve licensure.
- 8) The Respondent acknowledges that the Board will consider the underlying complaints and the psychological report in assessing the Respondent's character and fitness to practice should he choose to make application for licensure. Respondent acknowledges that the Board has discretion regarding the issuance of a license in the future.

### **Voluntary Waiver of Rights**

The Respondent, James K. Hanlon, D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.

## **Publication of Settlement Agreement**

The Respondent acknowledges that, once adopted by the Board, this Agreed Order may be considered a public document, available for inspection at any time by any member of the public under the Kentucky Open Records Act, and may be reportable under federal law. This Agreed Order may at any time be published on the Board's website, <a href="https://www.kbce.ky.gov">www.kbce.ky.gov</a>.

This Settlement Agreement consists of four (4) pages and embodies the entire agreement between the Kentucky Board of Chiropractic Examiners and James K. Hanlon, D.C.. It may not be altered, amended or modified without the express written consent of both parties.
