AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and Ryan Alexander Grand D.C., hereinafter referred to as the "Respondent."

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

History

WHEREAS, the Respondent answered "yes" to questions #10 and #15 on his 2016 Application for Annual License Renewal, requiring him to send in a paper application and supporting documents; and

WHEREAS, the Respondent's application was reviewed by the Board at its March 11, 2016 meeting; and

WHEREAS, the Respondent was sent a letter from the Board dated March 23, 2016, stating that the Board approved his renewal, however, it was

his responsibility in accordance with 201 KAR 21:015, to notify the Board of any outcomes within thirty (30) days; and

WHEREAS, the Respondent entered into a settlement agreement in the Circuit Court of the Nineteenth Judicial Circuit in Martin County Florida, and failed to report this action to the Board in violation of KRS 312.150(1)(g) and 201 KAR 21:015, Section (1); and

WHEREAS, the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that this matter shall be settled and resolved upon the following terms:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the Respondent under KRS Chapter 312 and the accompanying regulations;

2) The Respondent, Ryan Alexander Grand, D.C., accepts the reprimand of the Board for the above-stated violations, but admits no wrongdoing. The Respondent agrees to act more diligently in the future to insure he complies with KRS Chapter 312 and the accompanying administrative regulations;

3) The Respondent, Ryan Alexander Grand, D.C., shall pay a fine to the board in the amount of five hundred dollars (\$500.00), however that fine

shall be probated for a period of one year.

4) The original, executed Agreed Order must be received in the office of the board, *no later than November 17, 2017*.

5) Within six (6) months of signature of Agreed Order herein, Ryan Alexander Grand, D.C. shall attend the Jurisprudence course offered by the KBCE in Glasgow, KY; and

6) The Respondent shall complete Ethics and Boundaries course, but this requirement is probated for a period of one (1) year

7) The Respondent acknowledges that he is ineligible for participation in any chiropractic preceptorship program for two (2) years pursuant to 201 KAR 21:085, Section 2(7); and

8) The Respondent agrees to a suspension of his license to practice chiropractic for twenty (20) days, however the suspension shall be probated for a period of two (2) years. The probated suspension shall be served if and only if the Respondent violates KRS 312 or 201 KAR Chapter 21 within the probationary period and is convicted by the Board of that violation pursuant to the processes outlined in 201 KAR 21:051 or KRS Chapter 13B;

9) The Respondent, Ryan Alexander Grand, D.C., agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

Voluntary Waiver of Rights

The Respondent, Ryan Alexander Grand, D.C., has had the opportunity

at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.


Publication of Settlement Agreement


Complete Agreement


