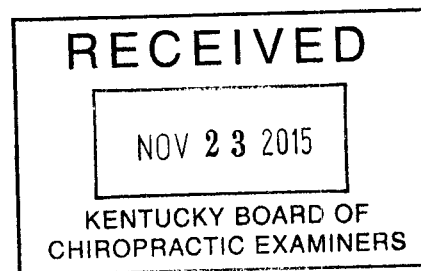

AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and Luke Ryan Young D.C., hereinafter referred to as the "Respondent."

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

History

WHEREAS, a complaint letter was mailed to the Respondent on July 17, 2015, and the Respondent did not file a response with the Board within twenty (20) days in violation of 201 KAR 21:051 Section 2(2); and

WHEREAS, the above-referenced letter was returned as undeliverable since the Respondent had failed to update his address as required by KRS 312.145 (4) in violation of KRS 312.150(1)(j); and

WHEREAS, the Respondent treated patients at the office of David Seastedt, D.C., as a fill-in doctor, but failed to sign the daily notes as the treating doctor in violation of 201 KAR 21:100, Section 1(2)(e); and

WHEREAS, the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that this matter shall be settled and resolved upon the following terms:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the Respondent under KRS Chapter 312 and the accompanying regulations; and

2) The Respondent, Luke Ryan Young, D.C., has offered to surrender his Kentucky chiropractic license in lieu of proceeding with disciplinary action in this case; and

3) The Respondent, Luke Ryan Young, D.C., agrees that should he ever attempt to be relicensed in Kentucky, he will have to complete the following terms for the referenced violations”

a. Pay a fine of two hundred fifty dollars (\$250.00) for violation of 201 KAR 21:051 Section 2(2); and

b. Pay a fine of two hundred fifty dollars (\$250.00) for violation of KRS 312.150(1)(j); and

c. Pay a fine of one hundred dollars (\$100.00) for violation of 201 KAR

21:100, Section 1(2)(e); and

d. The total fine of six hundred dollars (\$600.00) must be paid in full prior to reinstatement or relicensure.

4) The Board accepts the surrender of the Respondent's license effective the date of receipt of the original, executed Agreed Order by the Board.

Voluntary Waiver of Rights

The Respondent, Luke Ryan Young, D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.


Publication of Settlement Agreement


