AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and Craig S. Martin, D.C., hereinafter referred to as the "Respondent."

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

History

WHEREAS, the Respondent signed the Proof of Ownership form stating he was the owner of Associated Chiropractic and Rehab; and

WHEREAS, the Respondent informed the KBCE Field Coordinator that he did not know Brian Culliney; and

WHEREAS, the Respondent had previously reported to the Board on his 2010 License Renewal Application that Brian Culliney was the owner of Associated Chiropractic and Rehab and also his supervisor; and

WHEREAS, the Respondent has violated KRS 312.150 Section 1 (a); and

WHEREAS, the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that this matter shall be settled and resolved upon the following terms:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the Respondent under KRS Chapter 312 and the accompanying regulations;

2) The Respondent, Craig S. Martin, D.C., accepts the reprimand of the Board for the above-stated violations. The Respondent agrees to act more diligently in the future to insure he complies with KRS Chapter 312 and the accompanying administrative regulations;

3) The Respondent shall successfully complete the National Board of Chiropractic Examiners Ethics and Boundaries Examination within six months of entering this Agreed Order.

4) The Respondent shall complete the Kentucky Jurisprudence course before the license renewal deadline of March 1, 2012.

5) The Respondent shall provide to the Board sufficient proof of ownership of Associated Chiropractic and Rehab.

6) The Respondent, Craig Martin, D.C., shall pay a fine to the Board

in the amount of one thousand dollars (\$1000.00). Said fine shall be made payable to the "Kentucky Board of Chiropractic Examiners."

7) The original, executed Agreed Order, proof of ownership and fine must be received in the office of the Board, *no later than February 18, 2011*.

8) The Respondent acknowledges that he is ineligible for participation in any chiropractic preceptorship program for three (3) years pursuant to 201 KAR 21:085, Section 2(7); and

9) The Respondent, Craig S. Martin, D.C., agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the Board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

Voluntary Waiver of Rights

The Respondent, Craig S. Martin, D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.


Publication of Settlement Agreement


Complete Agreement




