AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and Adrian D. Nohr D.C., hereinafter referred to as the "Respondent."

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

History

WHEREAS, the Respondent has been named as the Defendant in a criminal case;

WHEREAS, the Board feels that an administrative hearing regarding the allegation related to the criminal action would be premature at this time; and

WHEREAS, the Board desires to protect the public until which time the criminal case is decided and the Board may take further action.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that the terms below shall be operative until such time as the criminal charges against the Respondent are resolved or the Board decides that further action is necessary for the protection of the public:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the respondent under KRS Chapter 312 and the accompanying regulations;

2) The Respondent, Adrian D. Nohr D.C., agrees to have a female witness in the adjusting and examination rooms with him at all times during care of women and children. Additionally, he agrees to have the witness record the time in and time out and sign each record;

3) The Respondent shall notify the Board office of all updates of any legal proceedings or findings, including but not limited to the entry of a plea, a sentencing or any other final disposition of that action;

4) The Respondent, Adrian D. Nohr D.C., recognizes that a representative of the Board may enter and inspect his facility at any time to verify compliance with the terms of this agreement;

5) The original, executed Agreed Order must be received in the office of the board, *postmarked no later than October 5, 2009*;

6) The Respondent acknowledges that he is ineligible for participation in any chiropractic preceptorship program until the administrative case relating to the underlying subject matter of this case is settled; and

7) The Respondent, Adrian D. Nohr D.C., agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

Voluntary Waiver of Rights

The Respondent, Adrian D. Nohr D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.


Publication of Settlement Agreement






