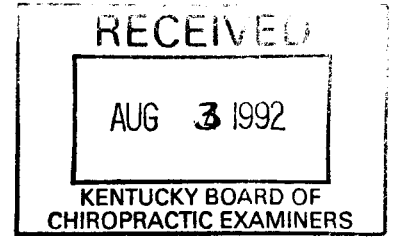

IN RE: THE LICENSE TO PRACTICE CHIROPRACTIC
HELD BY CAROL ELAINE WEBB, D.C.

AGREED ORDER

Come the parties to this action, Carol Elaine Webb, D.C. and the Kentucky Board of Chiropractic Examiners, and hereby state as follows:

1. That Carol Elaine Webb, D.C. failed to include notice of the seventy-two (72) hour right of rescission required by 201 KAR 21:080, Section 2, in an advertisement or solicitation in which she advertised free or discounted services recently. A copy of said advertisement or solicitation is attached hereto. Carol Elaine Webb, D.C. admits that by omitting to include said notice of the seventy-two (72) hour right of rescission she violated 201 KAR 21:080, Section 2, and she acknowledges that she is thereby in violation of KRS 312.150(1)(g).

2. That the parties hereto agree to resolve the above-mentioned violations by having Carol Elaine Webb, D.C. accept a total fine of \$1,000 pursuant to KRS 312.163(2), \$500 of which fine is to be paid to the Board immediately upon the signing of this Agreed Order by Carol Elaine Webb, D.C. This Agreed Order

and said \$500 portion of such fine are to be submitted to the Board no later than August 3, 1992. The remaining \$500 portion of said fine is hereby probated for a period of one year, with the conditions of such probation to be that Carol Elaine Webb, D.C. shall not violate any portion of KRS 312 or the regulations promulgated pursuant thereto during said one-year period of probation.

3. That Carol Elaine Webb, D.C. shall send letters, by certified mail, return receipt requested, to each of the consumers who responded to the attached advertisement or solicitation, and she shall submit to the Board a list of the names of all such consumers and copies of the letters sent to them by her. Such letters shall advise each of said consumers that she failed to include the seventy-two (72) hour right of rescission in said advertisement or solicitation in violation of 201 KAR 21:080, Section 2.

4. That the failure of Carol Elaine Webb, D.C. to perform any of the obligations which she has agreed to herein shall constitute grounds for the revocation of her above-mentioned probation.

5. By entry of this Agreed Order, Carol Elaine Webb, D.C. waives the right to a due process hearing as to the violations admitted to herein by her and she acknowledges that she has freely and voluntarily waived her right to counsel.

WHEREFORE, it is so agreed effective this 14th day of
July, 1992.
