**AGREED ORDER**

**Parties**

**WHEREAS**, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereafter referred to as the "Board," and Gregory S. Thomas, D.C., hereafter referred to as the "Respondent."

**Jurisdiction**

**WHEREAS**, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

**History**

**WHEREAS**, the Respondent mistakenly advertised a free or discounted service on a sign at the 2011 Kentucky State Fair, and the sign did not have on it any notice of the seventy-two (72) hour right of rescission required by KRS 312.019(9)(g) and 201 KAR 21:065, Section 3(1); and

**WHEREAS**, the parties mutually desire to settle the issue in an expeditious manner, without the need for a formal hearing.

**Terms of Agreement**

**Therefore, it is hereby agreed** between the undersigned parties that this matter shall be settled and resolved upon the following terms:

- 1) The Respondent has carefully reviewed the terms of this Agreed Order and enters into his Agreed Order knowingly, willingly and voluntarily and after a review of the due process rights afforded to the Respondent under KRS Chapter 323 and the accompanying regulations.
- 2) By entering into this Agreed Order, Respondent does not admit that he has violated any statute or regulation including KRS Chapter 312.
- 3) The Respondent agrees to accept the reprimand of the Board for what has occurred. The Respondent agrees to act more diligently in the future to insure that all advertising issued by the Respondent, or on Respondent's behalf, complies with KRS 312 and the accompanying regulations.

4) The Respondent has notified all consumers who signed up for a free consultation of the right of rescission as required by 201 KAR 21:065, Section 1(2).

5) The Respondent agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the Board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

**Voluntary Waiver of Rights**

The Respondent has consulted with competent counsel of his choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.


**Disclosure of Settlement Agreement**

The Respondent acknowledges that, once adopted by the Board, this Agreed Order may be considered a public document, available for inspection at any time by any member of the public under the Kentucky Open Records Act, and may be reportable under federal law.


**Complete Agreement**
