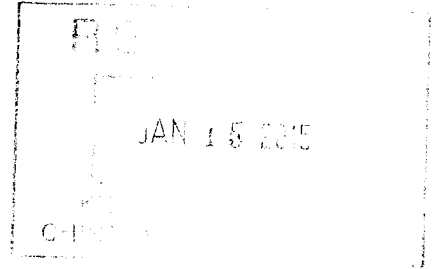

AGREED ORDER

Parties

WHEREAS, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the “Board,” and John J. Squicciarini D.C., hereinafter referred to as the “Respondent”;

Jurisdiction

WHEREAS, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations;

History

WHEREAS, the Respondent billed for services not rendered in violation of KRS 312.150(1)(f)(g) and KRS 312.150(2)(c)(d)(e); and

WHEREAS, the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

Terms of Agreement

THEREFORE, it is hereby agreed between the undersigned parties that this matter shall be settled and resolved upon the following terms:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the Respondent under KRS Chapter 312 and the accompanying regulations;

2) The Respondent, John J. Squicciarini, D.C., accepts the reprimand of the Board for the above-stated violations. The Respondent agrees to act more diligently in the future to insure compliance with KRS Chapter 312 and the accompanying administrative regulations;

3) The Respondent shall notify all insurance providers billed incorrectly and proof of reimbursement shall be mailed to the Board *on or before January 16, 2014*;

4) Within six (6) months of signature of Agreed Order herein, John J. Squicciarini, D.C. shall successfully complete (pass) the Ethics and Boundaries Assessment of the National Board of Chiropractic Examiners, with proof submitted to the Board; and

5) Within six (6) months of signature of Agreed Order herein, John J. Squicciarini, D.C. shall complete and additional twelve (12) hours of continuing education in Record Keeping/Documentation, with proof submitted to the Board. This shall be in addition to continuing education required for license renewal; and

6) The Respondent, John J. Squicciarini, D.C., shall pay a fine to the Board in the amount of five thousand dollars (\$5,000.00). Said fine shall be made payable to the "Kentucky Board of Chiropractic Examiners." The first

payment of one thousand dollars (\$1,000.00) shall be made on or before **January 16, 2015**. The remaining fine shall be due by **May 15, 2015**.

7) The original, executed Agreed Order and first fine installment must be received in the office of the Board, **postmarked no later than January 16, 2015**.

8) The Respondent acknowledges that he is ineligible for participation in any chiropractic preceptorship program for two (2) years pursuant to 201 KAR 21:085, Section 1(7); and

9) The Respondent, John J. Squicciarini, D.C., agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the Board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

Voluntary Waiver of Rights

The Respondent, John J. Squicciarini, D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.


Publication of Settlement Agreement


Complete Agreement






