APPROVAL OF MINUTES

Dr. Kuperus made a motion to accept the September 15, 2022 minutes as presented. Motion seconded by Dr. England, carried.

NEW BUSINESS

Dr. England made a motion to recommend regulation changes to 201 KAR 21:041 and 201 KAR 21:095 as follows:

Remove Section 3, (3)(a) 1. "A minimum of six (6) hours of the required twelve (12) hours obtained at a live event, which is an event at which both the licensee and presenter are present inperson;" from 201 KAR 21:041.

Remove "which shall be obtained at a live, inperson event within the Commonwealth of Kentucky; and" from Section 1, (2)(b) of 201 KAR21:095.

Motion seconded by Dr. Kuperus, carried.

Dr. England made a motion to recommend regulation changes to 201 KAR 21:025 Section 5 (2) to reflect biennial financial audit as stated in Section 5 (1). Motion seconded by Dr. Kuperus, carried.

OLD BUSINESS

Dr. England made a motion to recommend the board discontinue the existing PACE Pre-Check Expedited Course Submission for KENTUCKY form and the Kentucky Board of Chiropractic Examiners Continuing Education Application form and incorporate the newly drafted Kentucky Board of Chiropractic Examiners Continuing Education Application form for use. Motion seconded by Dr. Kuperus, carried.

Animal Manipulation discussion is ongoing. Committee will present current findings at board meeting and request authority from Board to continue animal manipulation discussion with the Kentucky Board of Veterinary Examiners.

Dr. England made a motion to correct 201 KAR 21:075 to state up to 5 members can be appointed to the Peer Review Committee. Motion seconded by Dr. Kuperus, carried.
