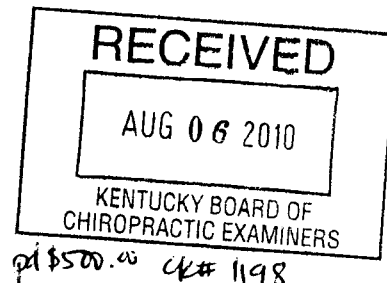

**AGREED ORDER**

***Parties***

**WHEREAS**, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and Keith Alan Jones, D.C., hereinafter referred to as the "Respondent."

***Jurisdiction***

**WHEREAS**, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

***History***

**WHEREAS**, the Respondent failed to provide his patient, M.W., a copy of her records within ten (10) business days as required by KRS 422.317 and KRS 312.150(1)(i); and

**WHEREAS**, the patient requested her records in September 2009 and did not receive her records until March of 2010; and

**WHEREAS**, the parties mutually desire to settle the issue in an expeditious manner, without the need for a formal hearing.

### ***Terms of Agreement***

**THEREFORE, it is hereby agreed** between the undersigned parties that this matter shall be settled and resolved upon the following terms:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the respondent under KRS Chapter 312 and the accompanying regulations;

2) The Respondent admits violation of KRS 312.150(i);

3) The Respondent, Keith Alan Jones, D.C., accepts the reprimand of the Board for the above-stated violation. This agreed order shall constitute the aforementioned reprimand. The Respondent agrees to act more diligently in the future to insure that he complies with KRS Chapter 312 and the accompanying administrative regulations;

4) The Respondent, Keith Alan Jones D.C., shall pay a fine to the board in the amount of five hundred dollars (\$500.00). This fine shall be in the form of a personal check or money order made payable to the "Kentucky Board of Chiropractic Examiners."

5) The original, executed Agreed Order and fine must be received in the office of the board, *postmarked no later than August 10, 2010.*

6) The Respondent acknowledges that he is ineligible for participation in any chiropractic preceptorship program for three (3) years pursuant to 201 KAR 21:085, Section 2(7); and

7) The Respondent, Keith Alan Jones, D.C., agrees that the failure to

comply with any of the terms and conditions of this Agreed Order may result in the board setting the matter for an administrative hearing in accord with KRS Chapter 13B. Further, the Respondent acknowledges that the violation of the terms of this order shall constitute an independent violation of KRS 312.150(f).

### ***Voluntary Waiver of Rights***

The Respondent, Keith Alan Jones D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order. The Respondent waives his right to appeal from this agreed order pursuant to KRS 312.160 or any other statutory provision providing for appeal of this order.

### ***Publication of Settlement Agreement***


The Respondent acknowledges that, once adopted by the Board, this Agreed Order shall be considered a public document, available for inspection at any time by any member of the public under the Kentucky Open Records Act, and may be reportable under federal law. Further, this agreed order constitutes a reportable disciplinary matter pursuant to KRS 312.160(2). express written consent of both parties.




