CALL TO ORDER

Dr. Johnson called the meeting to order at 12:09 p.m.

APPROVAL OF MINUTES

- **P.C. 2023 Renewal** – Dismissed with prejudice.
- **J.M. NPDB Report** – Ongoing investigation. Ineligible to reinstate until Indiana criminal case is completed.
- **ABC Complaint** – Ongoing investigation.
