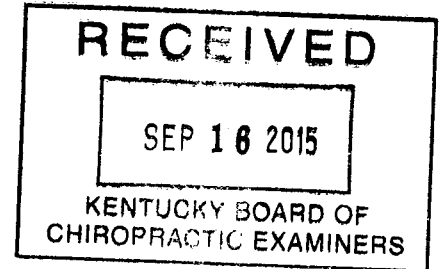

**AGREED ORDER**

***Parties***

**WHEREAS**, the parties to the Agreed Order herein are the Kentucky Board of Chiropractic Examiners, hereinafter referred to as the "Board," and Michael B. Furnish D.C., hereinafter referred to as the "Respondent."

***Jurisdiction***

**WHEREAS**, the Board has jurisdiction over this matter pursuant to KRS Chapter 312 and the related administrative regulations.

***History***

**WHEREAS**, the Respondent advertised on his website, [www.brentfurnishdc.com](http://www.brentfurnishdc.com), including statements which were false and misleading in violation of KRS 312.021 (1) and KRS 312.150(1)(d)(g); and

**WHEREAS**, the Respondent had previously entered into an Agreed Order in June 2008 for advertising violations; and

**WHEREAS**, the parties mutually desire to settle the issues in an expeditious manner, without the need for a formal hearing.

### ***Terms of Agreement***

**THEREFORE, it is hereby agreed** between the undersigned parties that this matter shall be settled and resolved upon the following terms:

1) The Respondent shall carefully review the Agreed Order herein and enters into this Agreed Order knowingly, willingly and voluntarily and after having reviewed the due process rights afforded to the respondent under KRS Chapter 312 and the accompanying regulations;

2) The Respondent, Michael B. Furnish, D.C., accepts the reprimand of the Board for the above-stated violations. The Respondent agrees to act more diligently in the future to insure that all advertising issued by the respondent, or on the respondent's behalf, complies with KRS Chapter 312 and the accompanying administrative regulations;

3) The Respondent, Michael B. Furnish, D.C., shall pay a fine to the board in the amount of one thousand dollars (\$1000.00). Said fine shall be made payable to the "Kentucky Board of Chiropractic Examiners."

4) The original, executed Agreed Order and fine must be received in the office of the board, *postmarked no later than September 25, 2015.*

5) On or before March 1, 2017, the Respondent shall complete the two (2) hour Kentucky Jurisprudence course; and

6) The Respondent shall come into compliance by updating all advertising, to include but not limited to website language, building and facility signage, to state "Chiropractic Neurology" wherever the word neurology appears, to be consistent with his training and to avoid misleading the public;

and

7) The Respondent acknowledges that he is ineligible for participation in any chiropractic preceptorship program for two (2) years pursuant to 201 KAR 21:085, Section 2(7); and

8) The Respondent, Michael B. Furnish, D.C., agrees that the failure to comply with any of the terms and conditions of this Agreed Order may result in the board setting the matter for an administrative hearing in accord with KRS Chapter 13B.

### ***Voluntary Waiver of Rights***

The Respondent, Michael B. Furnish, D.C., has had the opportunity at all times to seek advice from competent counsel of choice. No coercion has been exerted upon the Respondent, nor have any promises been made other than those reflected in this Agreed Order.

### ***Publication of Settlement Agreement***




### ***Complete Agreement***




the express written consent of both parties.
