Dr. Smith called the meeting to order at 12:07 p.m.

CLOSED SESSION

A motion was made by Dr. England to approve the following per diem:

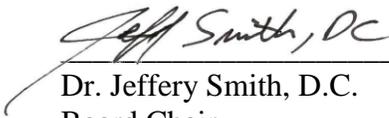
- Drs. Cooper-Henson, Henderson, England and Smith - June 26 Meeting
